This document is a User Guide for the Energy Tariff Incentive Program (ETIP 2.0) designed for New & Existing Companies. This manual includes an overview description of the ETIP, the auditing process, the criteria and all essential information needed to fulfil the program requirements. In addition, it provides guidance to the manufacturing entities on the requirements needed for enrollment. The program consists of three main criteria that manufacturing entities will be audited on to grant them one of the three categories based on the scoring system. Moreover, the Industrial Development Bureau will provide the guidance and support to the applicants through the auditing process journey of the program.

Terms and Glossary

Eligibility Criteria	A set of criteria which if achieved enables the industrial project to become eligible to qualify for energy incentive tariff.
Existing Companies	Manufacturing Entities which are in operation/production for more than 6 months from date of issue of the production/operational license from ADDED

Introduction

The Energy Tariff Incentive Program (ETIP 2.0) is an expansion of the Electric Tariff Incentive Program 1.0 (ETIP) to cover gas tariff in addition to Electricity Tariff for the industrial sector based on the eligibility criteria that includes economic impact, spending on logistics and the demand side management efficiency along with the energy management efficiency in the Emirate of Abu Dhabi. The program aims to support the private industrial sector by enhancing their economic impact and thrust their productivity by offering preferential Gas and Electrical rates to promote competitiveness in the Emirate of Abu Dhabi.

Objectives of the program

1. Enhancing the economic impact of the industrial sector in the Emirate of Abu Dhabi
2. Boost the manufacturing entity productivities in the Emirate of Abu Dhabi by encouraging technological transformation
3. Improve the efficiency of the energy usage in the Emirate of Abu Dhabi
4. Reduce industrial operation expenses

Stakeholders Roles and Responsibilities

Overall Description of Energy Tariff Incentives Program

The program was established to promote the competitiveness of Abu Dhabi as a manufacturing hub.

Entities can opt for obtaining certificate for the Energy Tariff Incentive Program pertaining to:

1. Electricity incentive
2. Gas Incentive
3. Electricity and Gas Incentive.

The evaluation criteria remains the same for economic impact and productivity. However, the last criteria is a variable element related to connection load and Energy Management systems where electricity is concerned and further Demand Side Management where gas is concerned.

Manufacturing entities can select their respective option and obtain separate certificates for Electricity and Gas.

For Electricity:

- **Discounts covers the consumption amount benefitted directly towards the manufacturing entity's electricity bill.**
- **Discount valid for one year and factories should apply for the next year**

If the manufacturing entity scored less than 50 points, the actual standard tariff prices will be charged accordingly.

For Gas:

- **Discounts covers the consumption amount which will be obtained through rebate mechanism paid directly to the beneficiary upon completion of each quarter.**
- **Discount valid for one year and factories should apply for the next year**

If the manufacturing entity scored less than 50 points, the actual standard tariff prices will be charged accordingly.

The Evaluation Criteria

1. Economic Impact

Economic Impact – aims to build a robust value chain in the industrial sector in the Emirate of Abu Dhabi by, creating employment opportunities for UAE nationals, increase the skilled resources and support the Logistics sector in the Emirate of Abu Dhabi.

For Economic impact for New Companies, the following attributes are considered:

- (i) Investment in Abu Dhabi;
- (ii) Investment Top Up Score.

2. Abu Dhabi (AD) Logistics

AD Logistics – aims to build a robust value chain across the logistics sector and its contribution to the industrial sector in the Emirate of Abu Dhabi.

For AD Logistics for New Companies, the following attributes are considered:

- (i) Abu Dhabi Logistics Charges;
- (ii) UAE logistics charges.

The weight of supply chain criteria with relation to the total score is 30%. For Existing Companies, the AD Logistics Criteria is part of the Economic Impact evaluation.

3. Productivity Criteria

Productivity refers to how well an organization converts input (such as labor, materials, machines and capital) into outputs. The productivity is important as it drives the economy towards growth and attracts more investments due to the increase in profit when productivity increases. Assessing productivity can help the manufacturing entities to reduce the risk of costly errors and improve the ways to do business. The productivity will be based on the value addition done by the manufacturing entity based on the total number of employees. Productivity output should be capped at 1 (i.e., does not exceed 100% of the score).

The Productivity Criteria is only applicable to Existing Companies.

The number of workers considered will be the number of workers paid under WPS of the entity as well as any outsourced workforce contributing to the entity.

The productivity score will be based on comparing the incremental improvement in the productivity ratio when taken in comparison to the previous year's actual productivity. The "Base Year Productivity" for those companies who will join for the first time will receive the full score as this will be their baseline.

Thus, previous year actual productivity will be used for evaluation of productivity score of each year for all the applicants after Base Year with degree of improvement over previous year productivity capped at 10%. A 10% improvement is progressive; thus a 10% improvement will correspond to a 100% productivity improvement score.

For the selection of industrial sector for any supplier, the major revenue stream from commercial activity will be considered, if a company has more than once revenue stream or production lines.

* Financial Income is excluded from the Revenue.

* Production cost is the cost incurred for the respective entity during the specified year of produced product.

4. Connection load and Energy Management System (Electricity):

The manufacturing entity will scan and submit its site power connection details forum and Single Line Diagram for Connectivity load. If the site is distribution connected for power, the connected load can be greater than, equal to or less than 5MW as stated in ADDC/AADC Site.

Both New & Existing Manufacturing entities irrespective of their connection load can be considered in the ETIP. For entities having more than 5MW, 10% will be considered while the other 10% will be reviewed against Energy Management System checklist. For Manufacturing entities having less than 5MW the full 20% will be reviewed against the Energy Management System checklist.

The total score of the connection load / EMS has a total weightage of 20%.

The Energy Management checklist as approved by ADDC/AADC will also be submitted for evaluating the company for energy efficiency parameter.

5. Demand Management System (Gas):

The manufacturing entity will scan and submit the respective gas demand data pertaining to their requested consumption and actual consumption in the preceding year. AD Ports being the Gas provider in the industrial zones, will provide the given percentages of consumption towards the initial requested demand. As per the agreement with AD Ports the applicable tariff for Gas will remain at 95% of the requested demand irrespective if the actual consumption is far less. Considering this aspect of Demand management, the ETIP program is looking to incentivize the accuracy and appropriate planning of the demand side and therefore will categorize scoring in this section as per the figure 4 below. For entities that are in the first year of contract with AD Ports, full score will be given under the Demand Management Side criteria.

Transitioning from Electric Tariff Incentive Program (ETIP 1.0) to Energy Tariff Incentive Program (ETIP 2.0)

As per the introduction, the ETIP 2.0 is an expansion of the previous program (Electric Tariff Incentive Program), where now it provides incentives for Gas as well. In line with the development of the program, there are some minor notable changes in the criteria however overall Economic impact and productivity elements remain the same. Some key points of the terms and conditions are listed below:

Energy Tariff Incentive Program

1. Entities can opt for Electricity, Gas or Electricity and Gas depending on their requirements.
2. All existing valid ETIP 1.0 will remain valid until their expiry date. Upon renewal, entities will need to renew under ETIP 2.0. All aspects will be applicable as per the new guidelines and AUPs which includes the progress of productivity from previous year.
3. Any entities joining the program for the first time will have the base line productivity and be eligible for the full productivity score.
4. Entities already having a valid ETIP 1.0 certificate who are opting to add the Gas initiative can apply for addition of benefit, utilizing the same data already used for the ETIP1.0. The only variable being the DMS score which needs to be ascertained in order to obtain a valid score for Gas. This can be applied through "Addition of Benefit" option. The validity of the certificate will remain the same as the existing ETIP 1.0 certificate, where the entity will then renew under the ETIP 2.0 for both Electricity and Gas.
5. All entities having existing ETIP 1.0 certificates will need complete the validity period and apply for ETIP 2.0 upon renewal. Entities will not be able to re-apply existing certificates under ETIP2.0 to obtain a higher score. No same financial statements can be used to apply for multiple ETIP certificates.
6. Entities who have expired ETIP 1.0 certificates and left the program, requesting to re-join under ETIP2.0 will still undergo evaluation under the criteria. Productivity and all related elements will still apply.
7. IDB reserves the right to evaluate each application independently and case to case approval of technical clarifications pertaining to the application and transition can be forwarded to IDB through the concerned Certifying Body for approval prior to engagement.
8. The Gas Incentive will not apply directly towards the billing, rather will be settled every quarter through rebate mechanism. This will require submission of consumption bills and proof of payment, along with bank account confirmation letter.

Procedures

1. A list of the required documents and forms can be accessed from <https://idb.added.gov.ae/en/incentives/etip>
2. Log in to the E- services using the existing portal username and password. <https://www.adbc.gov.ae/CitizenAccess/Welcome.aspx>
3. On the main dashboard menu select "Energy Tariff Request".
4. Select the industrial license number you want to obtain for the incentive.
5. Insert the contact details (name, email and phone number)
6. You will be taken to an upload screen to upload all the required documents as specified on the website.

7. Once all the required documents have been uploaded, you will be moved to the review page and CB's selection.
8. Click on submit application (RFQ).
9. The certifying bodies will review the documents and prepare the quotation, or you will be asked to submit further details before issuing the quotation (in this case you will receive a notification to complete the required documents).
10. When the certifying bodies issue the quotations, you will receive a notification about it.
11. Log in to your account and review the received quotations from the certifying bodies to award one of them.
12. The certifying body will start auditing the application based on the identified criteria. You can be contacted by certifying body for further clarification.
13. Based on your incentive choice, Distribution companies or AD ports will provide an input into the application (e.g., connection load or Demand Side Management) for approval or decline of information.
14. The certifying body will issue a balance score card specifying the achieved score in addition to that a report will be issued to summarize your scores.
15. You need to sign the balance score card.
16. If the manufacturing entity fulfills all requirements and achieves a score of 50 points and above, IDB will issue an enrollment certificate to the program specifying the final score and the awarded category. Kindly note that the validity of the enrollment certificate is (1) one year from date of issue.
17. For Electricity, you now need to approach one of the distribution companies with the enrolment certificate to obtain the new tariff for your industrial entity.
18. For Gas incentive, you will need to submit to IDB on quarterly basis:
 - a. Gas Consumption data for the completed quarter in the form of invoices and respective billing
 - b. Proof of payment supporting made in full toward the gas bills
 - c. Bank account confirmation certificate from the bank addressed to IDB (once annually)

Accordingly, this information to be submitted to IDB to apply for the rebate which will be paid direct to the beneficiaries account.

19. If the manufacturing entity score is below 50 points a regret letter will be issued from IDB, and you will be charged with the Standard Industrial Tariff.
20. For any renewal applications, certificate validity will start from the date of previous certificate expiry valid for one year as per the new score. Time frame for renewal application will be **60 days** prior to expiry date to obtain renewal terms of one year from expiry date. Any application renewed before this will result in certificate issue date on actual approval date of the renewal.

1- What is Energy Tariff Incentive Program?	The Energy Tariff Incentive Program 2.0 (ETIP) is an expansion of the Electric Tariff Incentive Program 1.0 (ETIP) to cover gas tariff in addition to Electricity Tariff for the industrial sector based on the eligibility criteria that includes economic impact, spending on logistics and the demand side management efficiency along with the energy management efficiency in the Emirates of Abu Dhabi. The program aims to support the private industrial sector by enhancing their economic impact and thrust their productivity by offering preferential Gas and Electrical rates to promote competitiveness in the Emirates of Abu Dhabi.
2- Who is eligible to apply for Energy Tariff Incentive Program (ETIP) program and does the Program cover other consumers than industrial?	All the industrial facilities in Abu Dhabi holding valid industrial license issued by the IDB are eligible to apply for the program. The Program was established by the Industrial Development Bureau to cover all Industrial sectors in Abu Dhabi except Free Zone Entities.
3- What type of industrial activities are included?	All industrial activities approved within the emirates of Abu Dhabi are applicable for the program.
4- What is the eligibility criteria for applying for the program as Existing Companies?	The industrial entities which are in operation/production status for more than 6 months from date of issue of the production/operational license from ADDED are eligible as Existing companies
5- What is the criteria for applying for the program as New Companies?	The industrial Entities which have "under construction" license issued by ADDED and/or companies which are in operation for first 6 months from the date of issue of "production/operational" license issued by ADDED
6- If my production license was issued in	Yes, the program is designed for all Entities both New and Existing with or without production status under

less than 1 year, can I apply to the program?	different ETIP program parameters. Separate application is processed as applicable for New or as Existing company. One company can be eligible only under one category as "New" or "Existing" based on approved definitions of New and Existing Company.
7- How does this program differ compared to Electric Tariff Incentive program?	This program is an expansion of the initial Electric Tariff incentive program where preferential gas rates has also been included. Manufacturing entities can choose to opt for Electricity only, Gas only, or both Electricity and Gas.
8- I am part of the existing Electric Tariff Incentive program; will I be affected and how can I continue to be part of the program?	All ongoing beneficiaries to the Electric Tariff incentive program will continue as per the dates on their certificate. Entities that will reapply for the certificate, will undergo evaluation under the Energy Tariff Incentive program. In this case the new revised criteria will apply, and productivity will be considered from the previous electric tariff incentive program certification.
9- I am part of the electric tariff incentive program, and would like to now apply for the Gas benefit?	The existing application for electricity and validity of certificate still stands. Entities can opt for certification of the gas incentive using the same financials and data that was used for electricity. The only evaluation required will be for the Demand Side Management which will consider the variable 20% in the scoring. The certification dates will be unified towards the existing Electricity incentive so that when reapplying, the entity can apply for both Electricity and Gas together under the new Energy Tariff Incentive Program.
10- I have an existing Electric Tariff Incentive program certificate. Can I re-certify to the new Energy Tariff incentive program?	No, all existing certificates will be active until their expiry. You can apply for energy tariff incentive program upon the expiry of your certificate. No same financial statements can be used to apply for multiple ETIP certificates. The only way to apply for Energy Tariff Incentive program is if the entity is new to the program or applying for Gas incentive addition to their existing certificate.
11- Who will have access to my documents	All documents will be managed confidentially by the designated teams.

12- What are the benefits from the Program?	Manufacturing Entities could potentially qualify for special tariffs based on a set of criteria reflecting their economic value and their cost-to-serve.

All applicants are required to provide the financial statements available for the last available financial year, such that the audited statements are not older than 18 months from the date the application reaches IDB for final review. For companies exceeding 6 months in operation and do not have audited financial statements, the management accounts for a period no less than 6 months can be used for ETIP calculations.

In case the supplier prepares consolidated financials for a group of companies and has more than one factory operating under the entity, then the supplier needs to submit the **audited financials** of each factory which should reconcile with consolidated financials. The audited financial statements must be IFRS compliant.

In case Supplier has consolidated or combined financials and it is not a group of companies having separate factories operating under the entity, however, operates with separate licenses under the same entity (such as branch license, commercial license, free zone licenses in other Emirates etc.) approval from IDB to be obtained prior to proceeding with ETIP application. This is for consideration from IDB if the consolidated financials can be considered, if separate audited standalone financials are required or whether Management Accounts breakup certified by the supplier can be accepted and the level of sampling that is required. 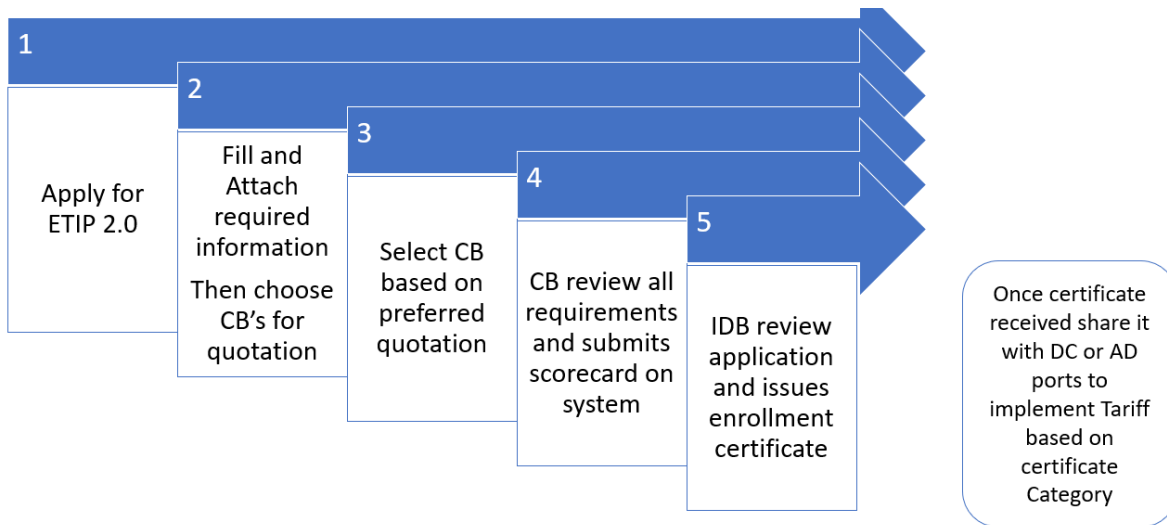

11. After review, if the manufacturing entity scores 50 points or above, IDB will issue an enrolment certificate specifying the energy type, final score, and approved category. However, if the manufacturing entity scores below 50 points, a regret letter will be issued from IDB, and you will be charged with the Standard Industrial Tariff.

Kindly note that the validity of the enrollment certificate is (1) one year from date of issue.
